**Admission of Foreign Nationals to Undergraduate Program for Academic  
Session 2025-2026**

Applications in **prescribed form** (available from [DUET Website](#)/Bangladesh Embassies/High commissions) are invited from foreign nationals for admission into the undergraduate programs in various departments of Dhaka University of Engineering and Technology (DUET) for the session 2025-2026. The application must be forwarded by the Foreign Ministry of the student's own country to the Ministry of Foreign Affairs of the Government of the People's Republic of Bangladesh, for necessary government approval and forwarding to the Ministry of Education of the Government of the People's Republic of Bangladesh.

On completion of all these necessary government formalities, the application should reach the Office of the Registrar, DUET by 27 August, 2026.

A student must not apply directly to the University for his/her admission.

### **1. Eligibility criteria**

- (a) Foreign nationals having completed their education in foreign countries shall be considered as 'Foreign Students'.
- (b) Candidates must have passed secondary school certificate examination or its equivalent examination from a foreign education board or the GCE "O" level examination after a minimum of 10 years schooling with a minimum 50% marks or equivalent GPA or grade.
- (c) Candidates must have a diploma in engineering or equivalent in any of the following branches or their relevant branches with a minimum 55% average marks or CGPA 2.75 (in a scale of 4.0) or equivalent CGPA in any other scale.

### **2. Number of seats**

The total number of seats for foreign nationals in undergraduate programs in a single academic session is 40 (Forty). However, a maximum of 05 (five) students from a single country and a maximum of 04 (Four) students in a single department shall be allowed.

### 3. Procedure for submission of application

Application must be submitted through the Ministry of Foreign Affairs of the Government of The People's Republic of Bangladesh. All relevant documents of educational qualifications and 4 (four) copies of recently taken colored photographs of the candidate should be included with the application form. After receiving the application(s), the Admission Committee will select the eligible candidate(s). However, the "Equivalence Committee" will determine the equivalence of educational qualifications of the candidates if necessary. Candidates must mention the numerical conversion value of respective grades (if necessary), and they must also mention the date of passing of the final examination of their diploma in Engineering

### 4. Tuition fees and other expenses

The tuition and other fees for undergraduate study for foreign Nationals except those from SAARC countries are US\$ 500 (Five hundred) only per regular semester. However, the Nationals of SAARC countries need to pay US\$ 250 (Two hundred fifty) in each regular semester of each academic session as admission/entry fees, and the tuition fees and other fees will be two times as that for the Bangladeshi students. Every foreign national will be considered a residential student.

Applications are to be submitted in triplicate to the Ministry of Education (those applying for medicine should do it to the Ministry of Health), Govt. of the People's Republic of Bangladesh through the Bangladesh diplomatic representative in the country of the candidate's domicile or the diplomatic representative of the candidate's Mission in Bangladesh. If the proposed admission is in pursuance of an agreement between the Govt. of Bangladesh & the Govt. of applicant's country or domicile, the application has to be routed through the Ministry of Foreign Affairs of that country of domicile.
4. All certificates and mark-sheets essentially be attested by the Foreign Ministry of the respective countries of the candidates' without which no application will be entertained.
5. Only for MBBS and BDS courses the applicant must enclose a non-refundable Demand Draft of US\$ 60 or BDT 5000
