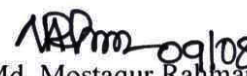

- He will submit the joining report along with the photocopy of his passport mentioning the arrival and departure date.

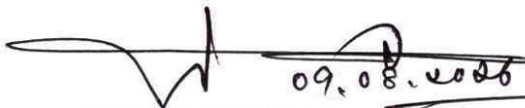
