- She will submit the joining report along with the photocopy of her passport mentioning the arrival and departure date.

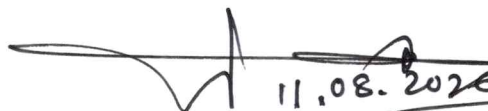
